

Dayton Wright Brothers Airport Terminal Upgrades

The **Dayton Wright Brothers Airport** complex offers business and recreation flying options in the southern Montgomery County/northern Warren County region. Spurred by the economic growth of Austin Landing and the immediate accessibility from I-75, investment in this Regional Airport will ensure the economic viability of the facility and support continued growth in the area. Upgrades to the terminal will enhance the customer experience and breathe new life into this facility. Proposed improvements to the airport are estimated to cost \$550,000 and include:

- upgrades to the terminal building envelope for energy and operational efficiency
- new entrance and drop off area to meet ADA requirements
- new terminal building vestibule to enhance energy efficiency and improve the customer experience.
- new lobby finishes to upgrade the airport's public face and image
- LED lighting installation

The existing terminal building is outdated and not current with energy codes and ADA requirements. As air travel increases nationally, Wright Brothers Airport represents a tremendous regional asset to capture the increasing demand for private air services. The proposed upgrades will enable the airport to handle increased traffic, represent the City of Dayton appropriately, meet energy codes and ADA guidelines, and reduce energy and operational expenses. Modernizing the terminal will position Wright Brothers Airport to be attractive to the emerging Air-Taxi services market and other new business. Thus, developing it as a Gateway to the region that is truly representative of the legacy of innovation the Wright Brothers represent and of our region's aviation history.

We respectfully submit this project for a \$500,000 grant request. This project supports the category of Transportation.

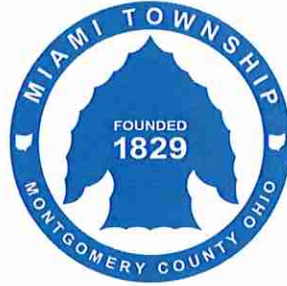
