The Sidney Canal Feeder Trail Connector and Great Miami River Trail is identified in the Ohio Resident Outdoor Recreation Survey 2017 Final Report, Trails for Ohioans publication, and is also mentioned in the US Army Corps of Engineers 2013 Great Miami Riverway Study.

The City of Sidney and Shelby County leaders are working to develop the final leg of the Great Miami River Recreation Trail, a 99-mile asphalt, off-street trail used by 90,000 trail users in the Miami Valley. The GMRRT's southern terminus is the City of Hamilton and stretches north along the Great Miami River to its current off-road terminus near Piqua in Miami County.

Project partners are seeking funding to add 12,200 feet of trail to an existing portion of the City of Sidney's Canal Feeder Trail at Kuther Rd. Connecting this final segment from Piqua to Sidney, and extending the Great Miami River Recreation Trail to the 20,550 residents of Sidney. Future phases of this trail construction will extend along the indicated multicolor path from Piqua to Sidney, as easements are granted, funds raised, and future grants are solicited.

I am writing on behalf of the Miami Conservancy District in support of the Shelby County Commissioners request to the Priority Dayton Region Priority Development and Advocacy Committee (PDAC), to fill in a key gap in the Great Miami River Recreation Trail from Kuther Road in Sidney to the Village of Lockington in Shelby County.

Connecting the almost 50,000 residents of Shelby County and Sidney to the entire Miami Valley Trail system, the nation's largest connected paved trail system, is important for several reasons: First, once this gap is filled, leaders from Piqua and Miami County have committed to working to connect Piqua to Lockington, which means that you will be able to ride, run, or walk uninhibited from Sidney to Middletown on the Great Miami River Recreation Trail.

Filling in this key gap also benefits every other community along the Great Miami River Recreation Trail, and many more people in SW Ohio who are currently part of the trail system.
